My thanks also to the board who have supported the team through the year, and in particular to the two vice chairs, Jenny Jamison and Phil Boughton. We have welcomed new board members following our governance review, and look forward to nominations for board membership from across the sector at our next AGM. We have emphasised the need for musicians to play their role in the governance and leadership of the sector, and Paul Philbert MBE, musician and board member, announced the creation of our Musicians' Advisory Council in his welcome to delegates at our conference in February 2022.

Addressing equity, diversity and inclusion remains a key focus for the sector and therefore for us as the ABO. Under Mark's guidance we are increasingly playing a leading role in this and other priority areas, and expect the ABO to continue to find its place as a thought leader and active agent for change.

Mark Pemberton has been the driving force of the ABO for 15 years. His dedication to the work of our members was recognised with an OBE in the New Year's Honours and an ABO Special Award at the conference in February. Fifteen years at the helm of any organisation is a remarkable achievement, and Mark's time here has included what many of us consider to be two of the greatest crises the orchestral sector has ever had to navigate. He has guided us with his customary calm authority and assurance throughout. Every one of us owes him an enormous debt of gratitude, I trust we will all find our own ways to express our thanks to our dear friend and colleague as he leaves us later this year.

INTRODUCTION



2021-22 saw the ABO membership emerge from the pandemic, with concerts and tours resuming, albeit with Covid-19 restrictions and reduced audiences. And it was also the year it became clearer as to the negative impact Brexit would have on the sector, both in terms of recruitment of EEA nationals and bringing artists into the UK, and touring into the EU.

The ABO continued to have regular dialogue with the UK Government and in partnership with other industry bodies was able to make progress on resolving the key obstacles that Brexit has thrown in our members' path. But it is clear that touring is more problematic than before the UK's exit from the EU, and the agreement struck between the EU and UK has dealt musicians and our members a poor hand.

Meanwhile, while we have welcomed the removal of Covid-19 restrictions, and are grateful to the Treasury for implementing a temporary uplift to Orchestra Tax Relief in response to our campaigning, we are concerned the Government is failing to recognise the long-term financial damage to the sector, and the impact of the pandemic on the well-being of musicians and managers alike.

The ABO itself also saw this as recovery year. A shift to a pay-to-attend model for its Specialist Managers Meetings, and higher than expected attendance at the hybrid conference, helped shore up our finances. The welcome addition of a member of staff to the new post of Head of Policy & Communications will however add to our costs in the coming years. We are hoping that members will recognise the benefits that flow from an increase in capacity, and will be willing to increase their investment in a strong and responsive association.

We are hugely grateful to the many partners who have worked with us this year. Our conference has benefited hugely from the support of its principal Media Partner Classic FM, Charity Partner Help Musicians and International Partner the British Council, and our thanks too to BBC Radio 3 for their input into the conference programme, as well to the many other sponsors who helped make the conference such a success. And we are grateful to the ABO Trust, Help Musicians and Vernon Ellis Foundation for supporting the Find Your Way programme, helping us maintain our commitment to nurturing the next generation of leaders.

We must also thank the British Council for their support of the International Mentoring programme and the UK-Australia Orchestral Connections symposia as part of the UK-Australia season. And our thanks too to Diana Ambache for her generous gift to the ABO Trust to support the Sirens programme.

On a personal note, I was delighted to have been awarded an OBE in the New Year Honours 2022, and an ABO Special Award at the conference dinner. My thanks to the board and the membership for all their support during this year. It is with some sadness that this will be my last Annual Review for the association, and I wish my successor the very best in taking the ABO to even greater heights.

REVIEW OF THE YEAR 2021/22

MISSION AND OBJECTIVES

The ABO Board agreed the following mission statement commencing I April 2019: The ABO's mission is to enable and support an innovative, collaborative and sustainable orchestral sector, and to provide advice, support, intelligence and information to the people who make British orchestras a global success.

The key Strategic Objectives of the Association cover three areas of activity:

- Connecting
- Championing
- Developing

Using the framework of the mission statement, our key aspirations for 2019-2022 will be to deliver on these key objectives through:

- **Connecting** members to other members and the wider industry through networking opportunities, keeping our members well-informed and up-to-date with best practice to help build resilience and financial sustainability.
- **Championing** orchestras and the wider membership, raising their profile and influence with key stakeholders and the British public, through political engagement, the media, social media and stakeholder bulletins. We will track and influence the development of legislation and government policies both in the UK and internationally, and advocate the value of public and private investment in the orchestral sector.
- **Developing** the skills and knowledge of our members' staff, including providing and signposting to high quality professional development opportunities and nurturing emerging leaders.

The annual Conference, in association with Principal Media Partner Classic FM, Digital Media Partner for Classical Music, Charity Partner Help Musicians and International Partner British Council, took place in Glasgow and online from 9-11 February 2022.

The Conference theme was Rebound. Speakers included Angus Robertson MSP, Cabinet Secretary for the Constitution, External Affairs and Culture; author, musician and social commentator Darren McGarvey; Gina Davidson, LBC Scotland Political Editor; Dr Dave O'Brien, Professor of Cultural and Creative Industries, University of Sheffield, Dr Anna Bull, Lecturer in Education and Social Justice, University of York; Paula Kemp, Head of Employer Engagement, Social Mobility Commission; Tarek Iskander, Artistic Director & CEO, Battersea Arts Centre; Elizabeth de Brito, musicologist and producer of The Daffodil Perspective; Pauline Black, Head of Music, University of Aberdeen; Deborah Keyser, Director, Ty Cerdd; John Wallace CBE, Chair, Music Education Partnership Group; Katie Razzall, Culture Editor, BBC News; Dame Susan Bruce, Chair, Royal Scottish National Orchestra; Phil George, Chair, Art Council of Wales; and Lord Mendoza, DCMS Commissioner for Cultural Recovery & Renewal.

Specialist Managers Meetings

Specialist Managers Meetings continued to form the backbone of the ABO's events programme, and the number of meetings and attendance increased during the year due to the Covid-19 crisis and shifting meetings online. The Specialist Managers Meetings provide opportunities for colleagues from different organisations to meet and discuss subjects of mutual interest and benefit from the latest developments in their field through talks and surgeries given by experts.

Meetings for Chairs & Trustees, Chamber Orchestras, Contract Orchestras, Concert & Orchestra, Education, Finance, Fundraising, Marketing and Stage & Transport Managers, along with Opera & Ballet, Scottish and Welsh members took place during the year, and we held the first Artistic Planners meeting since 2007. Meetings throughout the year were well-attended, with 773 total attendees, and provided much-valued forums for discussing the impact of the pandemic on the sector.

During the year, members heard from a range of external speakers from organisations including Black Lives in Music, Circular I Health, Marquee TV, City & Cambridge Consultancy, Cause 4, Purple 7 / TRG Arts, Nesta, Paul Hamlyn Foundation, PRS Foundation, The Audience Agency, Indigo Ltd, Department for Transport, and the Road Haulage Association.

The ABO also held an online Digital Summit in collaboration with BACH in July 2021 with 101 attendees.

Orchestral Connections

Throughout September we held an online symposium, Orchestral Connections, in partnership with Symphony Services International. This comprised four sessions with **257** total attendees zooming in from all over the world. The symposium was supported by the UK/Australia Season Patrons, the British Council, the Australian Government and Creative Partnerships Australia, through the Australia Cultural Fund as part of the UK/Australia Season 2021-22.

CHAMPIONING

Public Affairs

As well as providing advice, guidance and practical resources for members on a range of key issues, the ABO team continued to champion the value and role of British orchestras through our public affairs work, making the case to UK Government, the devolved administrations and the wider sector.

The ABO appointed Hanna Madalska-Gayer in the new role of Head of Policy and Communications in September 2021, to increase the team's capacity in managing the impact of urgent and complex public policy issues on our members, including Covid-19 and Brexit, as well as music education, access and sustainability.

The team have continued to meet regularly with Parliamentarians and representatives from the Government and funding agencies, and support and collaborate with wider cultural sector bodies, entertainment unions and campaign groups. This included organising an Orchestra Roundtable with Arts Minister Lord Parkinson and a Classical Music Roundtable with Shadow Arts Minister Barbara Keeley MP.

The ABO has worked tirelessly to support our members throughout the pandemic, providing guidance and clarification of Covid-19 protocols. We successfully made the case for sector funding support and sat on the DCMS working group, providing evidence of sector impact and input into Covid policy including workforce, audience and travel guidance. We continue to advocate for the long-term Government support needed for the sector's recovery.

The ABO has played an active role in engaging with the UK Government, the European Union and European partners on the challenges that Brexit poses for our members and its impact on international touring. Our advocacy work focuses on resolving issues of mobility – both inbound and outbound – of people and trucks, as well as customs and border control issues regarding carnets and CITES.

Advocacy work includes ABO submissions to Government consultations on behalf of our members, including the Department for Transport's consultation on specialist events hauliers operating in the EU under the Trade and Cooperation Agreement (TCA), the Department of Health and Social Care's consultation on COVID certification, and Culture, Media and Sport Select Committee inquiries.

The **All Party Parliamentary Group (APPG) on Classical Music** exists to bring together parliamentarians who have an interest in and wish to further the appreciation of classical music; to act as an interface between British orchestras' on and off-stage activities, the wider classical music industry, including broadcasters and the recording industry, and key decision makers and opinion formers; and to look at the potential for establishing parliamentary classical music awards and promoting and supporting young musicians. The ABO serves as the Group's secretariat, and advised parliamentarians during the year on various issues. Guest speakers at APPG meetings this year included Tom Hansell, Projects & Partnerships Manager from The Monteverdi Choir and Orchestras in November 2021; and renowned percussionist Colin Currie in February 2022 – each focusing on the effects of Covid-19 and Brexit on their work. Several APPG members were able to enjoy concerts kindly offered to the APPG by the Southbank Centre, with members attending the Royal Philharmonic Orchestra's Elgar's Violin Concerto, Aurora Orchestra's Beethoven's 7th Symphony and the Philharmonia's Wagner's Ring in November 2021.

We have widened our reach, sharing our seasonal e-bulletin, **ABO News**, highlighting news and information on the activity of ABO members, with a growing network of parliamentarians and key stakeholders.

Communications

Libby Binks of Sharp Arts Media served as the ABO's press consultant during the year, during which time she raised press interest in Find Your Way, Sirens, board appointments, the ABO Conference, the annual awards, and the award of an OBE to the ABO's Chief Executive.

ABO/MU Casual Concert/Freelance Orchestral Agreement

The ABO continued to negotiate the ABO/MU Agreement through its working party comprised of Mark Pemberton and Janet Marsden, ABO; John Harte, Aurora Orchestra; Elaine Baines, City of London Sinfonia; Alexander van Ingen, Philharmonia; and Jo Buckley, Dunedin Consort. Negotiations were concluded successfully for an agreement commencing I October 2021.

Awards

The **ABO Award** is presented annually to the individual or institution considered by the members to have made the most important contribution to the orchestral life of the UK. At the annual conference dinner, the ABO was pleased to announce the **Kanneh-Mason Family** as the recipient of this prestigious award.

An **ABO Special Award** was presented to its Chief Executive **Mark Pemberton OBE** to mark his service to the ABO and the work he had done in guiding members through the dual challenges of Brexit and the pandemic.

ABO/Classical Music Awards were presented to **Julia Desbruslais**, Executive Director, London Mozart Players (Orchestra Manager of the Year), **Roger Wright**, Chief Executive, Britten Pears Arts (Concert Hall Manager of the Year) and **Atholl Swainston-Harrison**, Chief Executive, International Artist Managers' Association (Artist Manager of the Year). A special Commendation Award was presented to **Matthew Sims**, Head of Arts and Venues for Leeds City Council, in the category of Concert Hall Manager of the Year.

The 2021 **ABO/RPS Salomon Prize** was presented jointly to **Jamie Hutchinson**, Sub-Principal Violinist, Oxford Philharmonic Orchestra and **Beth Higham-Edwards**, Percussionist, London Chamber Orchestra. **Amy Thomas**, Tutti Viola, City of Birmingham Symphony Orchestra, received a special commendation.

National Music Council and Music Education Council

The ABO is a member of the National Music Council, which exists to promote the interests of the music sector. The Director was re-elected as the NMC's Chairman in December 2021. It is also a member of the Music Education Council.

Pearle* and International Engagement

The ABO and its members benefit hugely from membership of Pearle* (Live Performance Europe), the European league of performing arts associations, which helps the ABO keep track of and influence legislative and regulatory developments within the EU and which holds twice-yearly conferences of its members. The Chief Executive attended its conferences online and then in person in Lucerne in October 2021. He also attended meetings of the Live Performance Sector Social Dialogue Committee in Brussels, which brings together employers' associations and trade unions from across the EU. Following the UK's departure from the EU, the ABO is no longer eligible to attend these meetings but was invited in order to speak to attendees on the impact of Brexit.

The ABO benefits from attending international conferences and engaging with colleagues abroad, through forging connections with arts leaders, orchestras and orchestral associations in other countries, and sharing and disseminating best practice to our respective memberships. With conferences shifting online due to the pandemic, the Chief Executive was able to attend and speak at Classical Next, League of American Orchestras and International Artist Managers Association events. Janet Marsden attended the IAMA Conference in Copenhagen on behalf of the ABO.

Website, Social Media and Update

The ABO's website continues to be an invaluable source of communication and information for members and the general public. Figures show that from I April 2021 to 31 March 2022 there were **66,596** visits from **33,664** unique visitors (an increase from last year's figure of 43,279 visits from 20,498 visitors) generating over **217,953** page views (previously I19,457). **53**% of users were from the UK, while the rest of from around the world. These figures are an excellent measurement of how valuable the website has become in communicating its message to members and the wider world.

The ABO has continued to "tweet" relevant news via Twitter to its **8,690** followers, and the hashtag for the ABO Conference was widely used by delegates as well as observers away from the conference. We have also increased activity on Facebook and LinkedIn, where we have **2,814** and **474** followers respectively.

The ABO continued to distribute its much-valued monthly members Update, supplemented by regular bulletins, and Education and Youth Ensemble e-bulletins.

DEVELOPING

The ABO continues to provide access to a range of briefing sheets on topics of relevance and concern to the membership, and provides up-to-date information on events and information via its monthly email Update for members. The ABO continued to offer advice for the benefit of its members, and we are grateful for the pro-bono advice on VAT provided by Graham Elliott, City & Cambridge Consultancy and tax advice from Evelyn Partners.

Family Arts Campaign



The ABO is a member of the Family Arts Campaign consortium and is represented on the Project Board. The Campaign is an Arts Council England Sector Support Organisation, with The Albany as the accountable body. Work on core activity continued, including promotion of the Family Arts Standards and Age-Friendly Standards quality mark. The Campaign delivered a programme of online learning opportunities in the past year, focusing on building skills and development to build better family arts work post-pandemic, including a digital conference in November 2021. In addition, the ABO has

supported the Campaign in its regional networks programme, whereby six Family Arts Ambassadors work at a local level across the UK to develop community family work.

The ABO will continue to support the Campaign in its redevelopment as an independent company as it applies to become an Investment Principle Support Organisation within ACE's Let's Create portfolio for 2023-2026.

Professional Development

The ABO was unable to run its regular training courses due to the pandemic.



Leadership Programme: Find Your Way 2021-22

The 2020-21 Find Your Way (FYW) programme finished with the residential course at Snape Maltings, 6-8 August 2021, which was the first in-person meeting for the cohort on the 2020-21 programme. Over the summer the ABO put out an open call for applications to the 2021-22 programme: eleven applications were received, and following zoom interviews of all eleven, six participants were selected. The 2021-22 programme was again jointly led by Richard Wigley, Wigley Arts Management and leadership trainer Andy Beaumont, with Fiona Harvey, the ABO's Education & Youth Ensembles Consultant as project manager. The ABO is grateful to Help Musicians, the Vernon Ellis Foundation and the ABO Trust for their continued funding of Find Your Way.

The mentors met with Andy Beaumont in early October; two of the mentors are FYW Alumni. The group's first meeting took place in October with James Ainscough, CEO, Help Musicians as guest speaker. The second meeting took place online in December, when the group met with Kathryn McDowell, Managing Director, London Symphony Orchestra and Lydia Connolly, Director, Harrison Parrott. Richard Wigley held one-to-one meetings with participants during October/November. A third group meeting took place in January at Bristol Beacon hosted by its CEO Louise Mitchell, where the guest speaker was Sophie Lewis, Managing Director, National Children's Orchestras. For the first half of the meeting the cohort were joined by thirteen FYW Alumni. The cohort curated a session at the ABO Conference in February, titled 'Rebound: Find Your Way', exploring what it means to be a good leader and questioning whether the pandemic has changed the way we lead. Two informal catch-up meetings were held online in November and January. We have continued to hold Zoom meetings for the FYW Alumni network which now includes 90 people.

The residential course was planned for 22-24 April 2022. The 2021-22 "Essentials of Find Your Way" was also planned for June and July 2022.

Leaders Retreat

The ABO held a retreat at Snape Maltings in September 2021 for eleven CEOs of orchestras, generously hosted by Roger Wright, CEO, Britten Pears Arts. Led by Andy Beaumont, leadership trainer, participants focussed on the tools needed to rebuild resilience, personal, organisational and sectoral. A further 10 people expressed interest and the ABO aims to hold another retreat in 2022.

EDUCATION & YOUTH ENSEMBLES PROGRAMME

The bi-annual Specialist Manager Meetings of Education Managers were held online. They continue to enable members to share their work and hear from guest speakers, representing participants in orchestral education projects or those who work with the participants such as teachers.

In June 2021 our guest speaker was Barbara Eifler, CEO, Making Music on their Adult Music Learning Manifesto (https://www.makingmusic.org.uk/campaigns-and-advocacy/adult-music-learning-manifesto-2020); Becky West, Regional Producer-North, Orchestras Live on their 'Classically Yours' 4 year impact report (https://www.orchestraslive.org.uk/projects/classically-yours); and Bridget Whyte, CEO, Music Mark and Peter Garden, Executive Director – Performance and Learning, Royal Liverpool Philharmonic on the recently published Model Music Curriculum

The November 2021 meeting included guest speakers Susannah Simons, Marquee TV, who talked about potential opportunities for orchestras' learning and participation programmes on new digital channels, and Bridget Whyte, Music Mark who gave a comprehensive overview of music education in all four UK nations

Music & Health

Following the launch of the 'Orchestras in Healthcare' report, the ABO continued to work in partnership with Orchestras Live and City of London Sinfonia, with the National Performance Advisory Group (NPAG) for Arts, Design and Heritage in Healthcare. NPAG's members run arts programmes in hospitals. They carried out a survey of NPAG members' work with orchestras and this resulted in a joint event held in January 2022, with over 100 people signed up. The event aimed to enable an exchange of information and to introduce orchestra and health colleagues to each other. The ABO is a strategic member of the Culture, Health and Wellbeing Alliance

Youth Ensembles

The bi-annual meetings for youth ensembles began in November 2021, chaired by Sophie Lewis, Managing Director, National Children's Orchestras of GB. An initial catch-up meeting had been held in June.

- Music Mark Conference, Brighton, theme: 'Fast Forward; Technology and Music Education.

British Council International Mentoring Programme

Following the ABO Conference, the British Council worked with the ABO on implementation of an International Mentoring programme for emerging leaders. A selection process took place in March 2021 and the following participants were matched with their mentors:

The four participants were invited to attend the ABO Conference in Glasgow. Health concerns, and visa delays meant that two were not able to attend in person, but instead joined the online conference. Jelena Milasinovic and Francisco Varela attended in person.

The programme was an overwhelming success and will be continued with British Council support in 2022/23.

ABO TRUST

The ABO Trust was a beneficiary of a legacy from the estate of Mrs Elizabeth Ashton Edwards in 2010. The trustees have agreed to make a grant to the ABO towards the costs of its Education & Youth Ensembles and Find Your Way programmes.

Sirens

The ABO Trust received a donation of £200,000 in 2016 from Diana Ambache to support the costs of the Sirens fund, to encourage the programming of works by historical women composers for a 10 year period. The fund has an annual end of February deadline. In 2021, we extended the deadline to the end of July and six awards were made as follows:

- National Orchestras For All: Augusta Holmès 'Andromède'
- Nevis Ensemble: Grace Williams 'Sea Sketches'

- Royal Scottish National Orchestra: Grażyna Bacewicz 'Divertimento for Strings/Divertimento Na Smyczki (1965)'
- Ulster Orchestra: Augusta Holmès 'La Nuit et L'amour'

Due to COVID-19 some of these works that were due to be performed in 2021 were postponed, and each orchestra revised plans for performances at later dates.

FINANCE

The ABO made a surplus for the year ended 31 March 2022 of £23,908. This resulted in reserves increasing to £279,243. Income was better than expected, with retention of, and growth in, membership subscriptions, a shift to pay-to-attend digital events, and higher than expected attendance at the hybrid conference.

MEMBERSHIP

The ABO continued to see huge loyalty from its members, with minimal cancellation of subscriptions, and a number of new and returning members.

Manchester Collective, Sinfonia of London and Solomon's Knot became new members whilst Orchestra of St Johns and English Sinfonia returned (Full). Bath Festival Orchestra, Scottish National Jazz Orchestra and Cyprus Symphony Orchestra joined as Associate members. Brass Bands England and Music at Oxford joined as Affiliate members, Tutti as Corporate Members, Muzikfermata as Sole Trader member and Thistle Music returned as a Sole Trader. A full membership list as at the end of the financial year is included in this Annual Review.



GOVERNANCE

The Board met five times during the year, ensuring scrutiny of the Association's activities and finances.

An Extraordinary General Meeting took place on 22 June at which **Jo Buckley**, *Chief Executive*, *Dunedin Consort* and **Paul Philbert MBE**, *Principal Timpanist* & *Player-Director*, *Royal Scottish National Orchestra*, were elected to the board.

The AGM on 30 November saw the retirement of **Peter Bellingham**, *Chief Excutive*, *Sinfonia Cymru*, with **Lisa Tregale**, *Director*, *BBC National Orchestra of Wales* elected to fill the vacancy.

Following an open call for candidates, **Leslie Kwan**, Founder and Managing Director, The Monarch Network and **Chris Loughran**, Senior Policy & Advocacy Advisor, The HALO Trust, were co-opted to the board in February 2021, and were re-appointed in November alongside **Ellen Gallagher**, Hamlins LLP and **Linda Merrick**, Royal Northern College of Music.

The ABO is grateful to **Laurie Watt**, former Senior Counsel at Charles Russell Speechlys, for his support as the Association's Honorary Legal Adviser.

STAFF

Mark Pemberton continued to serve as *Chief Executive*, **Jenny Daly** as *Membership & Operations Manager* and **Emily Singh** as *Office & Events Administrator*. During the year Jenny Daly took maternity leave, during which time her position was filled by Janet Marsden.

Hanna Madalska-Gayer was appointed to the new post of Head of Policy & Communications in September 2021.
